DW: Had asked for comments on floods on Facebook and received suggestion of improved signage, GCC view is that we have ample signage, but it must be sited in the right place and then removed after use, situation would be improved if sign on A38 states road is closed 2 miles ahead plus more mobile signs or a further drop down sign if allowed

Members agreed a further drop-down sign on Sandhurst Lane and a sign on A38 that states access to village only, flood warden will action this

Surface water from Twigworth was bad recently in several places, partly caused by blocked drain, and should be cleared as had impact on village, RE and DW will discuss with residents

A parishioner has told RE that the Ronson site has been dumping waste stone which is raising the flood plain. Members felt it had only limited impact on the village

Concern was raised that pictures of floods are all over social media

Noted Gigaclear outage as box was damaged but is now working

John Robinson's DRAFT notes on the meeting of Sandhurst Parish Council Footway Report item on Monday 2 December 2019 held in the Village Hall

Words in italics were not mentioned in Council but are pertinent to these notes.

Meeting attended by, Rosemary Elliott, Debbie Wilkins, Karen Wood, Cllr Mark Williams and Pauline Clarke

Members noted the report.

Land to the South of the Parish

The Pound Sandhurst Lane

The order to construct the steps/stile at the Pound had been received by SB who intends to complete the construction before the end of this month. Action SB ESA 23 first hedge in from the Pound

Agreement with HB that the line of ESA 23 be transferred at the first hedge in from the pound needs to be agreed with JK, the owner of the land, together with other items mentioned in the report. A draft letter has been drawn up and sent to RD by JPR. Action RD to contact JK for his permission

An estimate still has to be prepared for the stile that has to be constructed in the wooden fence at the north end of the hedge in question. The estimate will be less than the £200 available in the 19/20 budget. Council gave their approval to the expenditure for the stile if it is necessary. Action JPR

Kissing Gates 2019/20

It was agreed that RD should contact JK asap in order to obtain his agreement to the third kissing gate being erected on the Severn Way at the boundary of his land and the northern boundary of Ronson's land. Action RD to contact JK for his permission JPR to draft letter for signature by RD

Kissing gates 2020/2021 No further gates were specifically mentioned.

Action All to consider additional positions for January meeting

Complaints received in October 2019

The stile on ESA 33 off Base line still awaited attention. It was suggested that Robert Warren be contacted. Action RD The non-slip paving material had been put in place on the GCC bridge ESA7 by PROW but no work had been undertaken on the adjacent bridge. JPR had been unable to contact HB regarding whether similar material will be placed by PROW. The material was reported as excellent. Members requested the cost of carrying out similar work on other SPC's footpath bridges be obtained. Action JPR The stile on the Severn Way at the junction of JK's land and Moat Farm land is still unreachable by vehicles because of flooding. Action All to note
