John Robinson's DRAFT notes on the meeting of Sandhurst Parish Council Footway Report item on Monday 3 February 2020 held in the Village Hall

Words in italics were not mentioned in Council but are pertinent to these notes.

Meeting attended by, Rob Davies, Rosemary Elliott, Karen Wood, Cllr Mark Williams and Pauline Clarke

It was noted that JPR's report for this meeting was **not** attached to the agenda, **nor** were JPR's notes of the January meeting attached to the minutes. Neither PC's minutes or agenda appeared on the internet until the 1st February. No explanation was given.

Members noted the report and the actions that were being taken.

Land to the South of the Parish

ESA 23 first hedge in from the Pound

Agreement with HB that the line of ESA 23 be transferred at the first hedge in from the pound needs to be agreed with JK, the owner of the land, together with other items mentioned in the report. *This new route will be referred to as a permissive footpath as agreed with HG.* A meeting will be held on site when all the land is free of flooding. A draft letter will be drawn up by JPR and signed by RD.

Action JPR to confirm with JK for his permission to accept the permissive footpath and a letter signed by RD acknowledging this.

Estimate prepared for the stile that has to be constructed in the wooden fence at the north end of the hedge in question. The estimate for construction is not more than £50 and wooden post and rails will not be more than £50 after approval was given to use four of the Waymark posts in store at Barrow Farm. These sums were approved at your last meeting.

Action JPR to inform SB

Kissing Gates 2019/20

JPR had obtained agreement with JK and RD signed the confirmatory letter. No objection has been received. A scan has been taken. No utilities were found. RD agreed to liaise with SB regarding delivering the gate to the site. SB has said that providing the position of kissing gate was moved slightly towards the River Severn the existing cattle proof fence would stay intact.

Action RD and SB to liaise with one another

Hopefully the erection of the Kissing gate can be completed in time for SB to claim his fee for erection by the March meeting. If not, dispensation will have to be made for the sum to be charged to the 2019/20 budget.

Work still being undertaken. PS completed his survey of ESA 33&34 (Gloucestershire Way). Meeting on Thursday 6th Feb to discuss what has to be tended to.

Action JR to report to next meeting

<u>Kissing gates 2020/2021</u>

Members agreed to ordering a kissing gate from PROW at a cost of £150.96 which will be charged to the 2020/21 budget. PROW need to confirmation of this asap.

Action PC

A list of three kissing gate sites below were approved.

- 1) ESA 13 Cricket Ground entrance from PW's land farmed by SM.
- 2) ESA 31 Rear of Giles Cottage Garden into Moat Farm land.
- 3) ESA 1A Severn Way at junction of JK's land and Moat Farm.

Letters need to be sent to all affected owners and farmers seeking their permission which will be signed by the Chairman.

Action JPR and RD

Not approved.

4) ESA 16 Rodway Lane entrance into JS/RD's land. RD said he would see if a gap already present could be made smaller in order to stop fly tipping taking place.

First reserve

5) ESA 34 Gloucestershire Way at junction of PW's land and JS's land. Please note that JPR has met with AW who has repaired the existing stile. It was agreed that a kissing gate should be still considered as it is on the Gloucestershire Way.

Action JPR to speak to HG re kissing gate

Complaints received in October 2019

The stile on ESA 33 off Base line still awaited attention. JPR has met with AW who has repaired the stile.

Anomolies in the DFP

JPR referred to a government document produced in May 2012 below https://www.gov.uk/government/news/new-plans-to-simplify-recording-rights-of-way which is pertinent to this item and the final item referred to in these notes.

A meeting has been arranged with HG and Andrew Houldey who is in charge of PROW in Shire Hall next Monday 10th February to discuss anomalies.

Complaints received since December's meeting

Signing on Sandhurst Hill Bridle Way

Signs erected adjacent to the bridleway ESA2 were not present when visited by JPR on 19th January but a chance meeting took place with the owner of Sandhurst Hill, Richard Dowty when both agreed signing should be discussed. JPR agreed he would raise the issue of signing at the February's SPC meeting. This meeting resolved that the Chairman should contact Richard Dowty.

Action RD to arrange and report back

Kissing gate at the first hedge in off Base Lane ESA14 Gloucestershire

This gate was not functional as the adjacent gate and hedge had been removed. This alternative was chosen by walkers. JPR had met AW on site who in turn had spoken to PW who did not want the gate removed. JPR said in that case PW should have the gap in the hedge replaced making the kissing gate obligatory.

Action JPR to report back to next meeting

Preparing for 1st January 2026

Members noted the report and decided not to entertain more bridleways being considered in Sandhurst. It was noted that where equestrians use existing tracks which are not Bridleways or Restricted Byways they only do so with the expressed permission of the owner.
