02.04.21 Requests for Dispensation or other Declarations of Members Interests – None declared

03.04.21 Minutes of the Previous Meeting held on 1 March 2021.

These having been circulated were approved and would be signed subject to Covid 19 restrictions.

04.04.21 Matters Arising (not covered by an Agenda item). The Litter Pick was very well supported by the Community. The Parish Council Members appreciated their support.

The application did not include change of use of land from agriculture to equine for turnout and grazing facilities for the horses. The objections would be sent to Tewkesbury BC Planning.

13.04.21 Standing Items, Village Green and Recreation Ground. Rec Ground - The Annual Inspection by ROSPA was agreed. NB This has not been proceeded with as the price quoted had increased.

14.04.21 Footpath Report. Order to Raise with Simon Booth to erect a stile. Cost £120 plus contingency sum £20. Approved by Councillors. Letter agreed concerning Sandhurst Rangers. (Chairman to sign.)

15.04.21 Correspondence. It was agreed to discuss the footpath walks when all Councillors were present. The cost of the Defibrillator Plaque was approved as well as the purchase of a new Battery which was due in May.
