03.12.22 Request for Dispensation or Other Declaration of Members Interests – Cllr Elliott declared an interest in Bengrove Farm.

04.12.22 Minutes of the Previous Meetings held on 7 November 2022 having been circulated were approved and signed by the Chair.

05.12.22 Matters Arising – Wyevale Nurseries have been appointed to supply the whips/trees, will be delivered on 6 February 2023. A committee would be set up to deal with planting. Only 2 persons had been interested in the allotments. A community Garden would be a way forward.

06.12.22. Public Participation – Hazel Brown presented a report to the meeting concerning the Millennium Recreation Ground. Full details will be circulated to Councillors.

07.12.22 County Councillor Report – Apologies given.

08.12.22 Borough Councillor Report – The Police had been active in the Village following recent complaints. A granite barrier for the Playground had been obtained as the area had been cut up by vehicles driving around. The area would be rolled.

10.12.22 Planning – RE left the Room whilst the application from Bengrove Farm 22/01231/FUL was discussed and approved by Councillors.

22/01151/FUL – Abbots Lodge Farm Base Lane. Demolition of five agricultural buildings and the erection of four dwellings. This was discussed with the Chair advising that similar sites were located in the village. TW spoke about the access and flood water as well as the surveys required. The company representative advised these had been carried out. NB. Tewkesbury BC – Planning. Since the Meeting this application is awaiting decision.

Planning decisions 22/01047/TPO - The Carltons, Sandhurst Lane – Consent. 22/00846/FUL – Wallsworth Lodge Sandhurst Lane – Permit.

11.12.22 Standing Items Village Green / Playground. A repair to the Playground equipment had been made by Greenfields.

12.12.22 Footpath Report – Dog Fouling signs had been placed on the footpaths.
